The team is ready to take the field!

The list of galleries that will participate in the 10th edition of **MIA Photo Fair**, the art fair dedicated to photography and moving image in Italy directed by **Fabio Castelli** and **Lorenza Castelli**, has been defined.

The final exhibitors are **87**. They will showcase the most outstanding projects in the art market, from the **19th until the 22nd of March 2020** at **The Mall - Porta Nuova (Milan)**.

The quality and prestige of the exhibition was guaranteed by the Scientific Committee, composed by **Fabio Castelli**, **Gigliola Foschi** and **Enrica Viganò**, which has reviewed the proposals and curatorial projects received from Italian and international galleries.

The main nucleus of galleries of MIA Photo Fair comes from Italy. But MIA Photo Fair counts also on a large group of galleries from abroad (30%): from **France** (Fisheye Gallery, Paris; GalerieSit Down, Paris; GalerieVéroniqueRieffel, Paris, Bel-Air Fine Art, Paris), from **Belgium** (Galerie Baudelaire, Antwerp), from **Germany** (Galerie STP, Greifswald, Drawing Room, Hamburg), **England** (ArtNoble, London), **from the Netherlands** (Suite 59 Gallery, Amsterdam; Project 2.0/ Gallery, The Hague, Gallery LiljaZakirova, Heusden), from **Spain** (Pigment Gallery, Barcelona), **from Hungary** (TOBE Gallery, Budapest, Mizerak Foundation, Odz), from **Switzerland** (Imago Art Gallery, Lugano), from **Greece** (Kourd Gallery, Athens; L,a,boutique Fine Art, Athens), from **Russia** (EVA Gallery, Moscow), and other countries from the Mediterranean area, such as **Morocco** (AfricanArty, Casablanca), **Turkey** (Versus Art Project, Istanbul) and **Israel** (GuruShots, Tel Aviv).

The others continents will be represented by galleries from the **USA** (Barry Friedman Collection, New York; Photo Independent, Los Angeles), **China** (Lele Gallery, Shanghai), **and Australia** (Preface Gallery, Perth).

MIA Photo Fair will present a special section called "**Beyond Photography - Seventies**", curated by **Elio Grazioli**, in which galleries will present some of the Italian protagonists of that period, who experimented conceptually and through the technique the transition from the traditional documentary and reportage photography of the late Sixties, to the experimental or aesthetic photography, within the artistic avant-garde, carried out by those "artists who used photography" as a contemporary art language. The section is composed by solo shows presented by eight galleries (**Galleria Clivio**, **Die Mauer**, **Galleria Elleni**, **Peliti's**, **Il Ponte**, **Galleria Melesi**, **Photo & Contemporary**, **Galleria Six**) which will showcase the works of some of the masters who participated in that season, such as **Lamberto Pignotti**, **Gianfranco Chiavacci**, **Aldo Tagliaferro**, **Paolo Gioli**, **Luca Maria Patella**, **Luigi Erba**, **Franco Fontana**, **Michele Zaza**.
